Additional Guidance notes	Your leaflet should include diagrams which enhance the report but do not take away from the flow of the text or your ability to show your understanding in your own words. All diagrams must be clearly referenced.

Your discussion and examination and the application of the knowledge will be totally clear.
Additional Guidance notes	It is important that you do not simply repeat facts and theories as read, but that you place them in your own words in the context of the tasks set to demonstrate your understanding. The ability to select the relevant information demonstrates your understanding of the topic and the tasks. Ensure that all information is clearly referenced.
